 ACKNOWLEDGING & APPOINTING MEMBERS TO THE SENIOR CENTER
 ADVISORY COUNCIL

WHEREAS, the Board of County Commissioners met in a regularly scheduled meeting on Tuesday, January 4, 2011 at 10:00 AM in the Socorro County Annex Building, 198 Neel Ave., Socorro, New Mexico; and,

WHEREAS, the Board of County Commissioners has created the Socorro City/County Senior Center’s Advisory Council; and,

WHEREAS, the Board of County Commissioners adopted the Bylaws of the Council on October 27, 2004; and,

WHEREAS, the Bylaws declare that purpose of the Council is to serve in an advisory capacity to the Director of the Socorro County Senior Program which includes making recommendations regarding the program, advising on the program’s compliance with the Older American’s Act of 1965, giving seniors a voice and channel through which their needs and ideas are heard, assist in conducting public meetings, developing strategies to reach the isolated elderly, to assist in the recruitment of volunteers and to testify and make presentations at local and state legislative hearings & meetings; and,

WHEREAS, Article VI Section 1 of the Bylaws declare that, with the exception of one member appointed by the City of Socorro and one member appointed by the Village of Magdalena, the “County Commission will be responsible for appointing members” of the Council; and,


NOW, THEREFORE, BE IT RESOLVED, that the below appointments be acknowledged and approved in accordance with Article IV Section 1 of the Bylaws.






PAULINE JARAMILLO
DISTRICT I




DANIEL P. MONETTE

DISTRICT III




RUMALDO J. GRIEGO
