AUTHORIZING 2011 CDBG PLANNING GRANT APPLICATION

A RESOLUTION OF THE COMMISSION OF THE COUNTY OF SOCORRO, NEW MEXICO, AUTHORIZING THE SUBMISSION OF A NEW MEXICO COMMUNITY DEVELOPMENT BLOCK GRANT PROGRAM APPLICATION TO THE DEPARTMENT OF FINANCE AND ADMINISTRATION/LOCAL GOVERNMENT DIVISION; AND AUTHORIZING THE COMMISSION CHAIR TO ACT AS THE COUNTY OF SOCORRO'S CHIEF EXECUTIVE OFFICER AND AUTHORIZED REPRESENTATIVE IN ALL MATTERS PERTAINING TO SOCORRO COUNTY PARTICIPATION IN THE COMMUNITY DEVELOPMENT BLOCK GRANT PROGRAM.

WHEREAS, the need exists within the County of Socorro for neighborhood improvement projects in several low and moderate income neighborhoods, and The County of Socorro desires to apply to the Housing and Urban Development's Community Development Block Grant Program to obtain funding for neighborhood improvement projects; and

WHEREAS, the need exists within the County of Socorro for applicable comprehensive planning in order to achieve those improvement projects; and

WHEREAS, the Commission has held one public hearing for public input and comment during the 2011 application process; and

WHEREAS, the Commission finds that there is a significant need to update and apply the Socorro County comprehensive plan; and

WHEREAS, the Commission determines that the Socorro County Comprehensive Plan meets the requirements of the Community Development Block Planning Grant Program.

NOW, THEREFORE BE IT RESOLVED BY THE GOVERNING BODY OF THE COUNTY OF SOCORRO, NEW MEXICO; that

1. The County of Socorro is hereby authorized to prepare and submit a Community Development Block Grant application to the New Mexico Department of Finance and Administration/ Local Government Division for the Socorro County Comprehensive Plan.
2. That the Commission directs and designates the Commission Chair as Socorro County's Chief Executive Officer and Authorized Representative to act in all matters in connection with this application and the County of

Socorro's participation in the New Mexico Community Development Block Grant Program.

3. The County of Socorro officials and staff are directed to do any and all acts necessary to carry out the intent of this Resolution.
4. That the application be for \$50,000.00 of grant funds to carry out updating the Socorro County Comprehensive Plan;
5. That it further be stated that the County of Socorro is committing their required 5% local match from their general fund as a cash contribution toward the development of a comprehensive plan.




