RESOLUTION № 2011-45
APPOINTMENT OF LODGERS TAX ADVISORY BOARD MEMBERS

WHEREAS, the Board of County Commissioners met in a regularly scheduled meeting on Tuesday _____, 2011 at 6:00 P. M. at the Socorro County Annex Building at 198 Neel Avenue in Socorro, NM; and

WHEREAS, the Board of County Commissioners created the Lodgers Tax Advisory Board with the adoption of the Socorro County Lodgers' Occupancy Tax Ordinance 2011-003 on September 13, 2011; and,

WHEREAS, Section 7 (A) of Ordinance 2011-03 provides that "[t]he Chairman of the of County Commissioners subject to confirmation by the Board of County Commissioners, shall appoint an advisory board of five residents of the County, two of whom shall represent the lodging industry, two of whom are directly involved in tourist related industries, and one member at large who shall represent the general public;" and,

WHEREAS, Section 7 (B) of Ordinance 2011-03 declares that the "term for all members of the advisory board shall begin on the first day of January in even numbered years, and shall expire on the last day of December, two years thereafter, or when each member's respective successor has been duly appointed and qualified. Members may be reappointed for up to two additional successive terms;" and,


WHEREAS, Section 7 (E) of Ordinance 2011-03 ordains that the function of the Advisory Board is to "make recommendations to the Board of County Commissioners concerning the expenditure of the Occupancy Tax proceeds [] prepare semiannual budgets, setting forth the amount of money collected [] and also setting forth all expenditures made during such semi-annual period;" and,


