DISPOSITION OF OBSOLETE, WORN-OUT OR UNUSABLE TANGIBLE PERSONAL
PROPERTY

WHEREAS, the Board of County Commissioners met in a regularly scheduled meeting on Thursday, June 14, 2012 at 10:00 a.m. in the Socorro County Annex Building 198 Neel Ave., Socorro, New Mexico 87801; and,

WHEREAS, pursuant to NMSA 1978 Section 4-38-1 (1884) the powers of a county as a body politic and corporate shall be exercised by a board of county commissioners; and,

WHEREAS, NMSA 1978, Section 4-38-13 (1953) provides that board of county commissioners shall have power at any session to make such orders concerning the property belonging to the county as they may deem expedient; and,

WHEREAS, NMSA 1978 Section 13-6-1 (2007) declares that a County may dispose of tangible personal property by public auction so long as the property is of a current resale value of five thousand dollars (\$5,000) or less and is worn-out, unusable or obsolete to the extent that the item is no longer economical or safe for continued use by the County; and,

WHEREAS, a designated committee of at least three Socorro County Officials has declared that all of the tangible personal property that is the subject of this resolution meets the criteria set forth in NMSA 1978, Section 13-6-1(A)(2007) and each member has duly sworn and subscribed under oath of its finding.


NOW THEREFORE, BE IT RESOLVED, by the Board of County Commissioners of Socorro County that:

1. It finds that the property described in Exhibit "A" attached hereto and incorporated with this Resolution by reference consists of property owned by the County of Socorro that is of a current resale value of five thousand dollars (\$5,000) or less and is worn-out, unusable or obsolete to the extent that the item is no longer economical or safe for continued use by the County.
2. A copy of this Resolution and Exhibit "A" shall be sent to the State Auditor at least 30 days before the disposal of the property pursuant to NMSA 1978, Section 13-6-1(B)(2)(2007).
3. A copy of this Resolution, Exhibit "A" and the findings of the committee shall be made a permanent part of the official minutes of the County and maintained as a public record subject to the Inspection of Public Records Act.


4. The property described in Exhibit "A" shall be disposed of at an online auction through Public Surplus.





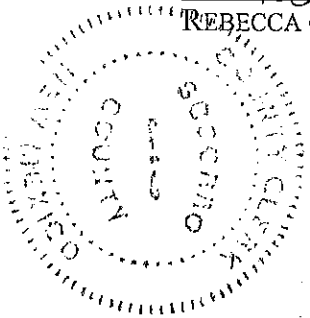
