PARTICIPATION IN LOCAL GOVERNMENT ROAD FUND PROGRAM ADMINISTERED  
BY THE NEW MEXICO DEPARTMENT OF TRANSPORTATION

**WHEREAS**, the County of Socorro and the New Mexico Department of Transportation have entered into a joint and coordinated effort.

**WHEREAS**, the total cost of this project will be **\$122,361.00** to be funded in proportional Share by the parties hereto as follows:

- a. New Mexico Department of Transportation share shall be 75% or **\$91,771.00** and
- b. Socorro County's proportional matching share shall be 25% or **\$30,590.00**

**TOTAL PROJECT COST IS \$122,361.00**

Socorro County shall pay all costs, which exceed the total amount of \$122,361.00.

**Now therefore, be it resolved** in official session that Socorro County determines, resolves, and orders as follows:

The project for this Cooperative agreement is adopted and has a priority standing. The agreement terminates on December 31, 2013 and the County of Socorro incorporates all the agreements, covenants, and understandings between the parties hereto concerning the subject matter hereof, and all such covenants, agreements and understandings have been merged into the written agreement.

**NOW therefore, be it resolved** by the Socorro County to enter into Cooperative Agreement Project Number SB-7753(928). Control Number HW2L100096 with the New Mexico Department of Transportation for LGRF Project for year 2013 to "Chip seal .6 miles & blade patch-CR-224 Martino Road (from NM-304 to Kuntz); chip seal 1.1 miles & blade patch-CR-224 Kuntz Road (from Wallner to Romero)' and chip seal .7 miles, striping and blade patch-CR-95 Lopezville Road and ext of Newberry."
