 RESOLUTION No 2012-75

NEW MEXICO TAXATION & REVENUE DELINQUENCY LISTING
 FOR REAL PROPERTY -TAX YEARS 2002 THRU 2009

WHEREAS, the Board of County Commissioners met in a regularly scheduled meeting on July 24, 2012 at 10:00 A.M. in the Socorro County Annex Building, 198 Neel Ave., Socorro, New Mexico; and,

WHEREAS, NMSA 1978, Section 7-38-61 states . . . by July 01 of each tax year, the County Treasurer shall prepare a property tax delinquency list of all real property for which taxes have been delinquent for more than two years. . . . The County Treasurer shall record the tax delinquency list in the office of the County clerk and there shall be no recording fee for recordation of the tax delinquency list; and,

WHEREAS, a copy of the front page and the page containing the recording information shall be provided to the Bureau Chief of the Delinquent Property Tax Bureau; and,

WHEREAS, Regulation 3.6.7.70 states . . .the County Treasurer shall deliver to or mail to the New Mexico Taxation and Revenue Property Tax Division the tax delinquency list for real property for the tax year to the division no later than July 15 of each year; and,

WHEREAS, recording of delinquency list is acceptable via CD.

NOW THEREFORE, BE IT RESOLVED, by the Socorro County Board of County Commissioners, that the real estate parcels identified by this resolution consist of 5,225 parcels totaling \$942,199.89 less Assessor's unidentified parcels \$36,700.41 leaving a net delinquent of \$905,499.48 (approx 65% Rio Grande Estates) breakdown 1st by Tax Year then by location as follows:
