**NEW MEXICO TAXATION & REVENUE DELINQUENCY LISTING
FOR REAL PROPERTY – TAX YEARS (2009 – 2016)**

WHEREAS, the Board of County Commissioners met in a Regular Meeting on Tuesday, August 13, 2019 at 9:00 am in the Socorro County Annex Building, 198 Neel Ave., Socorro, New Mexico; and,

WHEREAS, pursuant to NMSA 1978 Section 4-38-1 (1884) ...by July 01 of each year, the County Treasurer shall prepare a property tax delinquency list of all real property for which taxes have been delinquent for more than two years...The County Treasurer shall record the tax delinquency list in the office of the County Clerk and there shall be no recording fee for recordation of the tax delinquency list: and,

WHEREAS, a copy of the front page and the page containing the recording information shall be provided to the Bureau Chief of the Delinquent Property Tax Bureau ; and,

WHEREAS, Regulation 3.6.7.70 states>>>> the County Treasurer shall deliver to or mail to the New Mexico Taxation and Revenue Property Tax Division the delinquency list for real property for the tax year to the division no later than July 15 of each year; and,

WHEREAS, recording of delinquency list is acceptable via CD
